1. Call to Order

Phil M. called the meeting to order at 11:05 am.

3a. RI USDA- NRCS State Conservationist

Gina F. put forward an idea to hire someone part-time with an accounting background to do some of the accounting for the RIACD agreements and for SRICD/Fresh Harvest Kitchen. SRICD attendance at the Nov. 2 annual conservation dinner was discussed. Phil M. shared that he attended the legislative meet and greet in Portsmouth. Gina F. shared a key issue on the agenda of the Rhode Island Farm Bureau meeting is the Farm Tax exemption and resale tax from the Rhode Island Department of Taxation and the impacts to the farm stands.

Gina F. reported that we received RI Foundation funding of \$50 K. No word on the national coastal resiliency funding. The district and the town of Westerly received a Bridge Builder award from SNEP. SRICD is assisting the Town of Westerly with the urban tree canopy grant and technical assistance for tree planting on Main Street. On behalf of the SRICD, she submitted the NACD application on which we are waiting to hear back. SRICD received the urban agriculture grant of \$60K for urban areas within SRICD, primarily West Warwick, to assist underserved communities. Gina F. has been asked to sit on a municipal committee.

Phil M. recommended per the guidance that two members run for re-election to the board: Katy K. for a three-year term and Phil M. for a two-year term with an election to be held on November 12 at Fresh Harvest Kitchen. Phil M. made a motion seconded by Clark C. The motion was approved unanimously.

Phil M. requested that we publish a notice about the election as a paid ad in the newspapers in the district no sooner than Oct. 29 but no later than Nov. 4. The election will take place at the Fresh Harvest Kitchen from 9 am – 7 pm. Phil M. made a motion to appoint Christine C. and Gina F. to serve as election tellers. Katy K. seconded. The motion passed unanimously.

A discussion ensued about recruiting diverse associate board members including folks with an urban agricultural background. Gina F. will ask the planners for ideas for folks in Kent and Washington County.

NOAA written comment period on CRMC

Gina F. shared that we are in the 10-year review period for CRMC. NOAA is looking for public comment by October 25. Gina F. expressed her concern about members being political versus having technical assistance.
